- (b) Alternatively, for a fresh Order of this Honourable Court instituting parental access on an interim basis for the benefit of the Appellant and the child, [REDACTED] [REDACTED], born April 27, 2006.
- (c) An Order expediting the within appeal by setting the matter down for early hearing date(s);
- (d) An Order pursuant to Rule 52 of *The Court of Appeal Rules* for Saskatchewan, that the Applicant (Respondent) be awarded the costs of this application.
