Please note we are interested in obtaining a copy of a putative written custody agreement between the mother and the prospective third parties which may be on your file. Furthermore, it has come to our attention that an officer with ICFS for Montreal Lake (one ██████████) may have had involvement with this case on behalf of your client which would render discontinuance against the Minister premature at this time. In addition, DCR may (through workers or other personnel) have had oversight or involvement with the circumstances in which the care of the child was transferred from the mother to the prospective third parties which may also render discontinuance premature. These aspects of the case were not known to us when we earlier expressed an opinion regarding the timing of discontinuing as against your client.

Are you able to provide us with a copy of the agreement referenced above?

In any event, it is not on our intention on the upcoming return date to seek specific relief as against your client, as ours of September 1 indicates.
